**RESOLUTION #141-2011:** **RESOLUTION AUTHORIZING TAX REFUNDS**  
  
Tax overpayments to accounts occur when payment is received from two sources, such as a mortgage company and a title company or when a senior citizen or veteran deduction is granted to a resident and their taxes are already paid, or when the County Tax Board Judgment or New Jersey State Tax Court Judgment reducing the assessment on the property, therefore reducing the amount of taxes due for the year. This Resolution authorizes a refund of the payments.
